




Suicides and Suicide Rates in MA, 2010-2020

Age-Adjusted Suicide Rate (Per 100,000)






Suicides and Suicide Rates by Sex in MA, 2010-2020



Suicides by Age in MA, 2020





Suicide Rates by Race/Ethnicity in MA, 2016-2020





Suicide Rates by Race/Ethnicity among Youth Under Age 25 in MA, 2016-2020

Age Distribution of Suicides by Race/Ethnicity, 2016-2020





Circumstances Associated with Suicides in MA, 2020

98% of suicide decedents had at least one known circumstance




Circumstances Associated with Suicides in MA, 2020

98% of suicide decedents had at least one known circumstance

Females were significantly more likely to have a history of suicide attempts compared to males (**36%** vs. **17%**)


Males were more likely to disclose their suicide intent compared to females (**14%** vs. **10%**)



Circumstances Associated with Suicides in MA, 2020

98% of suicide decedents had at least one known circumstance


The proportion of decedents with physical health problems was heavily dependent on age: from **5%** among those under 45 years of age to **43%** among those 65 years or older




ED Syndromic Surveillance

- Collects data from 100% of EDs across Massachusetts
 - January 2019-September 2022
- Uses chief complaint text fields and ICD codes to identify visits associated with issues of concern, including:
 - Suicidal ideation
 - Suicide attempts
- Collects basic demographic data (e.g. age, sex, race/ethnicity, county of residence)


Total Weekly ED Visits

Overall Observations

- Overall suicide rates declined 2 years in a row
- Not all groups have been experiencing declines in recent years
 - Hispanic/Latinx
 - Asian, non-Hispanics
- Youth suicides show higher proportions of non-White decedents compared to other age groups
- ED visits for suicidal ideation and suicide attempt are higher in 2022 compared to 2021
 - Mostly driven by increases seen in young females age 15-24
