RE: Strong support for H.2221 & S.1384, An Act relative to student mental health

Dear Chair Domb, Chair Velis, and Honorable Members of the Joint Committee on Mental Health, Substance Use, and Recovery:

On behalf of the Massachusetts Association for Mental Health (MAMH), I write to urge the passage of H.2221 & S.1384, *An Act Relative to Student Mental Health* (Reps. Jack Patrick Lewis and Natalie Higgins, Sen. Jo Comerford), which would require public and charter schools serving students in grades 6-12 and institutes of higher education to print the number for the 988 Suicide & Crisis Lifeline on student identification cards.

According to a 2024 poll by the National Alliance on Mental Illness, while 67% of Americans said they have at least heard of 988, only 23% say they are somewhat familiar with the service. Suicide remains the second leading cause of death among people ages 15 to 24 in the Commonwealth. H.2221 & S.1384 present an opportunity to raise awareness about this free, life-saving resource, which is available 24/7 to support people in times of crisis.

Support for increasing awareness of the 988 Suicide & Crisis Lifeline has been gaining traction in the Commonwealth and across the nation. Seventeen states have already enacted legislation that requires crisis line numbers on college and university student identification cards. In 2019, Boston 25 News highlighted how some schools in the Commonwealth have begun adopting this practice, primarily led by students.ⁱⁱⁱ

We appreciate your and your colleagues' dedication to improving the mental health and well being of the Commonwealth's residents. We wholeheartedly appreciate your collaboration in shaping a healthier future for generations to come.
